The above approval if granted after rectification of deficiencies would be subject to the fulfillment of the following general conditions:

That the management shall provide adequate funds for development of land and for providing related infrastructural, instructional and other facilities as per norms and standards laid down by the Council from time to time and for meeting recurring expanditure.

- (a) That the admission shall be made only after adequate infrastructure and all other facilities are provided as per norms and guidelines of the AICTE.
 - (b) That the admissions shall be made in accordance with the regulations notified by the Council from time to time.
 - (c) That the curriculum of the course, the procedure for evaluation/ assessment of students shall be in accordance with the norms prescribed by the AICTE
 - (d) That the institution shall not allow closure of the institution or discontinuation of the course(s) or start any new course(s) or alter intake capacity of seats without the prior approval of the Council.
 - (e) That no excess admission shall be made by the institution over and above the approved intake under any circumstances. In case any excess admission is reported to the Council, appropriate penal action including withdrawal of approval shall be initiated against the institution
 - (i) That the institutions shall not have any collaborative arrangements with any Indian and/ or Foreign Universities for conduct of technical courses other than those approved by AICTE without obtaining prior approval from AICTE. In case any violation is reported to the Council, appropriate penal action including withdrawal of approval shall be initiated against the Institution
 - That the institution shall not conduct any course(s) in the field of technical education in the same premises/ campus and / or in the name of the institution without prior permission/ approval of AICTE. In case any violation is reported to the Council, appropriate penal action including withdrawal of approval shall be initiated against the institution
 - (h) The Institution shall not conduct any non-technical course(s) in the same premises/ campus under any circumstances. In case any violation is reported to the Council, appropriate penal action including withdrawal of approval shall be initiated against the institution

- That the institution shall operate only from the approved location, and that the institution shall not open any off campus study centers/ extension centers directly or in collaboration with any other institution/ university/ organization for the purpose of imparting technical education without obtaining prior approval from the AICTE.
- That the fution and other fees shall be charged as prescribed by the Competent Authority within the overall criteria prescribed by the Council from time to time. No capitation fee shall be charged from the students/ guardiens of students in any form.
- 5 That the accounts of the Institution shall be audited annually by a certified Chartered Accountant and shall be open for inspection by the Council or any body or persons authorized by it
- 6 That the Director/ Principal and the teaching and other staff shall be selected according to procedures, qualifications and experience prescribed by the Council from time to time and pay scales are as per the norms prescribed by the Council from time to time.
- 7 (a) That the institution shall furnish requisite returns and reports as desired by AICTE in order to ensure proper maintenance of administrative and academic standards.
 - (b) That the technical institution shall publish an information booklet before commencement of the academic year giving details regarding the institution and courses/ programmes being conducted and details of infrastructural facilities including faculty etc. in the form of mandatory disclosure. The information booklet may be made available to the stakeholders of the technical education on conjugate. The mandatory disclosure information shall be put on the Institution Website. The information shall be revised every year with updated information about all aspects of the institution.
 - (c) That it shall be mandatory for the technical institution to maintain a Website providing the prescribed information. The Website information must be continuously updated at and when changes take place.
 - (d) That a compliance report in the prescribed format along with mandatory disclosures on fulfillment of the above conditions, shall be submitted each year by the Institution within the time limit prescribed by the Council from time to time i.e. 31st August 2007 for the current year.
 - (e) That if Technical Institution fails to disclose the information or suppress and/ or misrepresent the information, appropriate action could be initiated including withdrawal of AICTE approval.
- 8 That all the laboratories, workshops etc. shall be equipped as per the syllabil of the concerned affiliated University and shall be in operational condition before making admissions.
- 9 That a library shall be established with adequate number of titles, books, journals both Indian & Foreign) atc as per AICTE norms.
- 10 That a computer center with adequate number of terminals, Printers etc. shall be established as per AICTE norms.
- 11 AICTE may carry out random inspections round the year for verifying the status of the Institutions to ensure maintenance of norms and standards.
- 12 That the AICTE may also conduct inspections with or without notifying the dates to verify specific complaints of mis-representation, violation of norms and standards, mal-practices etc.
- 13 That the Institution by virtue of the approval given by Council shall not automatically become claimant to any grant-in-aid form the Central or State Government.

students avenues for proper employment opportunities siter completing graduation, science graduates may be permitted to join Engineering courses at second year along with the diploma holders through lateral entry.

6,2 (b) Eligibility:

For being eligible to seek lateral entry to an Engineering degree programme at the second year/third semester level, a candidate must have passed the Degree in Science (B.Sc.,), with Mathematics as a subject and with a minimum of 60 percent marks in the aggregate. Only candidates fulfilling these conditions would be eligible for appearing in the entrance test meant for selection of B.Sc., graduates for Lateral entry to an Engineering degree programme. The selection of candidates will be based on an entrance test, the merit ranking in the test being the basis of admission.

The affiliating University may exempt 8.Sc., degree holders form Science courses and other relevant courses at the second year level and prescribe compensatory courses to makeup deficiencies.

(7) Extent of Lateral Entry

Diploma holders and 8.5c Degree holders shall be eligible for admission to second year Engineering degree programmes up to a maximum of 10% of sanctioned intake, which will be over and above the approved intake (supernumerary). In addition, these candidates shall be eligible for admission in the second year against the vacant seats at first year level. The concerned Admission Authority shall decide the ratio between the diploma holders and 8.5c graduates for admission.

(a) interpretation

If any question arises as to the interpretation of these Regulations, the same shall be decided σ_{ℓ} the Council.

The Council shall have the power to issue clarification to remove any doubt which may arise in regard to implementation of these Regulations.

(9) Power to relax

The Council may, in exceptional cases, for removal of any hardship or such other reasons to be recorded in writing, relax any of the provisions of these Regulations.

- Particulars of each beneficiary including name and rank of the students who have been granted unifort fee waiver in each discipline branch of study, and
- Details of the students admitted against the additional seats including name and rank etc., according to merit prescribed for regular admission

The Institutions shall also display such information in their websites for information to the students and other stake holders.

7. The tuition fee waiver to a student shall be for the duration of the course i.e. four years for flachefor courses in Engineering & Technology. Pharmacy. HMCT and Applied Arts, and Crafts, and three years for Diploma students and five years for B. Arch course. Once a student is given Tuition fee Waiver, the same shall be continued for the normal course duration.
