B.E/B.T. and M.Tech/M.C.A from a leading or Textile Tech or Textile University or Mdu Mdu (including its Branch) of Textile Studies, with first Division in either B.E.B.Tech or M.Tech from 2005 onwards. B.E/B.Tech in relevant branch of Engineering (Textile Engg., textile design). At least one successful PhD, published papers, 10+ experience and minimum 4 years publication of R&D research. I.A.R.T. ACT approved list of journals. Minimum of 10 years experience in managing industrial unit of atleast 5 years shall be at the post of directorate of Business. However the details of selection committee will be final.

Experience

Minimum of 15 years experience of managing research, industry, unit or project at senior level shall be at the level of Director.

Age

The maximum age for applicant should be 57 years as on the date of advertisement. However the applicants who have valid experience up to date of selection committee will be final.
